Re: Operations at San Francisco International Airport

Dear Mr. Paul:

We understand that your company and/or drivers in contract with your company may be operating at San Francisco International Airport ("SFO"). SFO is owned by the City and County of San Francisco and operated by the Airport Commission. Sidecar does not have a permit to operate a business on SFO premises. In the absence of an operating permit or the express permission of the Airport's Director to conduct business on Airport property, the continued operation of any Sidecar services at SFO is an unlawful trespass.

YOU ARE DIRECTED TO CEASE AND DESIST ALL OPERATIONS TO AND FROM AIRPORT PROPERTY IMMEDIATELY.

Please provide a copy of this notice to all Sidecar drivers. Further, please refer to SFO's Rules and Regulations, including the following:

Rule 3.3(E): No person shall enter or remain on Airport property and buy, sell, peddle or offer for sale or purchase any goods, merchandise, property or services of any kind whatsoever, on or from Airport property, without the express written consent of the Director or the Director's duly authorized representative.

Rule 2.2: Any person who violates, disobeys, omits, neglects or refuses to comply with any of the provisions of these Rules and Regulations or any lawful order issued pursuant thereto may be denied use of the Airport by the Director, in addition to the penalties described pursuant to federal, state or local authorities.

Rule 9.0: No person shall operate a business on Airport property unless in possession of a valid Airport Operating Agreement, permit, lease, or under authority granted by the Airport Director or his/her designee.


